# **FIREWORKS DESCRIPTION**

THE FOLLOWING FIREWORKS WILL BE DISPLAYED: State law requires this permit to specify the kind and quantity of fireworks. The Wisconsin Department of Justice has determined that the term "Class C" does not satisfy the requirement.

1. Permit Application needs to be submitted 15 days prior to event
2. A separate Permit is required for each day of fireworks display
3. Town Fire Dept and the Sheriff's Dept will be notified 48 hours prior to the event that a permit has been approved by the Town.
4. The Town of Seymour does not have a separate ordinance governing the use of fireworks. Compliance with State Statute 167.10 is required.
5. As per 167.10(7m) *"No city, village, or town, or committee, official, or employee of a city, village or town, is civilly liable for damage to any person or property caused by fireworks for the sole reason that the city, village, or town issued a permit in accordance with the requirements of sub.(3) and any applicable requirements authorized under sub. (5), that authorized the purchase, possession, or sue of the fireworks."*
6. It is recommended that the Permit Holder confer with an insurance adviser on adequate insurance coverage for their respective event.
7. Fireworks are to be used only between the hours of 4:00 pm and 11:00 pm. Please remember that not all of your neighbors appreciate or can tolerate the loud noise from fireworks for extended periods of time. Oftentimes pets become very distressed. Please be respectful.
8. Fire danger is always a concern. Please review the DNR brochure that is provided. As a reminder, parts of the Town of Seymour are in a Wild Fire Protection area.
9. If a profession Pyrotechnic Company will be hired, the following should also be provided:
  - *Name of Company*\_\_\_\_\_
  - *Address and Phone No of company*\_\_\_\_\_
  - *Site Plan detailing firing site, fallout perimeter, location of spectators and fireworks storage area*
  - *Insurance Certificate from the Pyrotechnic Company*
