I WILL MAKE SURE THAT MY PRACTICE AREA IS SAFE AND SECURE AND I WILL ABIDE BY ALL SAFETY RULES AND ORDINANCE RESTRICTIONS

2.1-1.0230 Bows and arrows may be discharged within the restricted area for target practice. Bow hunting can be allowed in the restricted area with the permission from the board.

- A. Makes all necessary safety precautions to protect the public and participants.
- B. Assumes full responsibility for injury or damage which might result.

An archery permit is valid only upon the land area described in the permit and shall be subject to any restrictions the Town Board prescribes.

**THE TOWN BOARD SHALL REVIEW EACH PERMIT APPLICATION ON A CASE-BY-CASE BASIS, AND IT SHALL BE ENTITLED TO PLACE ANY RESTRICTIONS OR DENY ANY PERMITS AS IT DEEMS NECESSARY TO PROVIDE FOR THE PUBLIC SAFETY AND ORDER.**

**AN ARCHERY PERMIT IS VALID ONLY UPON THE LAND AREA DESCRIBED IN THE PERMIT, AND SHALL BE SUBJECT TO ANY RESTRICTIONS THE TOWN BOARD PRESCRIBES.**
